RE: Academic Student Employee and Graduate Student Researcher Salary Scales New Title Codes and Titles for Academic Personnel

Dear Colleagues:

In accordance with the contractual agreement between the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (UAW) and the University of California, enclosed are the University's 2017-18 salary scales for the Academic Student Employees (ASE). Pursuant to the terms of Article 29, Wages, of the contract, the ASE salary scales have been adjusted by a general range adjustment increase of 3% with an effective date of October 1, 2017 for monthly paid employees and the first pay period commencing after October 1, 2017 for bi-weekly paid employees.

All ASEs should receive the 3% general range adjustment (see attached Tables 18, 19, and 20). For titles in the ASE bargaining unit whose rates are not maintained by the Office of the President (for example, Associate in _____ and Acting Instructor-Graduate Student titles at the Berkeley campus), each campus will need to ensure that the 3% increase prescribed in the agreement is implemented.

The San Francisco campus has indicated that employees in teaching titles that are not in the ASE bargaining unit (for example, Readers, Remedial Tutors, Teaching Assistants, and Teaching Fellows at the San Francisco campus) shall receive the 3% increase, effective October 1, 2017 for monthly paid employees and the first pay period commencing after October 1, 2017 for bi-weekly paid employees.

In addition, the salary scales for Graduate Student Researchers and Graduate Student Assistant Researchers are adjusted by 3% (see attached Table 22), effective October 1, 2017 for monthly paid employees and the first pay period commencing after October 1, 2017 for bi-weekly paid employees.

Furthermore, effective July 24, 2017, campuses with Clinical Psychology Interns and Non-Physician Clinical Trainees who are not affiliated with medical centers may use the following new title codes and titles in the Corporate Title Code System.
