Dear Colleagues:

In accordance with the contractual agreement between the University Council – American Federation of Teachers (UC-AFT) and the University of California, enclosed are the 2011-12 salary scales for the Non-Senate Instructional Unit 18 titles of Lecturer and Supervisor of Teacher Education. Per the agreement, the rates have been adjusted by 3% effective October 1, 2011. For titles in the Unit 18 bargaining unit whose rates are not maintained by the Office of the President (for example, the *Demonstration Teacher* title used at the Los Angeles campus), each campus will need to ensure that the 3% increase prescribed in the agreement is implemented.

As you know, last November the Board of Regents approved funds in UC's budget to provide a 3% pool for merit-based salary increases for faculty and non-represented academic appointees for 2011-12. The represented Non-Senate Instructional faculty will participate in the same academic one-time merit based increase program with a 3% increase effective October 1, 2011. Increases are to be awarded based on receipt of a positive review during the most recent review action. Unit 18 pre-six appointees are eligible if they were appointed or reappointed for the 2011-12 academic year. Unit 18 pre-six and continuing appointees who are paid on a by-agreement basis are not eligible for an increase. In addition, Unit 18 pre-six and continuing appointees who are currently subject to discipline as defined in Article 30 of the contract are not eligible for a merit-based salary increase.
