Report on Project Savings Funded from Capital Outlay Bond Funds

Project Savings

Consistent with Item 6440-401 of the Budget Act of 2012, this report is on the use of identified savings in construction funds appropriated from the 1990, 1992, 1996, 2004, and 2006 Higher Education Capital Outlay Bond Funds. For the item identified above, the Budget Act states that by December 1 annually the University of California shall provide the Legislative Analyst with a report showing the identified savings by project and the purpose for which the identified savings were used for the prior year.

During the 2015-16 fiscal year, the University of California used these provisions to authorize the use of project savings from the following project.

UC Santa Cruz

• In 2015-16, there were \$1,024,000 in project savings from the Infrastructure Improvements Phase 2 project (Chapter 21/2012, Item 6440-301-0705 and 0658[1]). The campus was authorized on August 10, 2015 to transfer project savings in the amount of \$489,000 to the College Eight and Kresge Academic Buildings Elevator Modernizations, and project savings in the amount of \$535,000 to the Classroom Seating Replacement and Minor Upgrades project. The scope of the two projects included elevator modernizations, replacement of fixed seating, correction of water intrusion issues, and other required repairs in State supportable space.
