 - Corequisite(s)
- o Courses with significant or substantive changes, including changes in:
 - Content
 - Course Objectives

- If you do not plan to update your TCA this year, notify me by email and copy Holly Deme at ASSIST (holly@assist.org).

If a course you submitted for review last summer or fall was placed under faculty review and you never received a response, please feel free to resubmit this summer. Any supplemental information you can provide (e.g. a UC or approved CCC course that you believe your course is comparable to) is very helpful in the review process.
