Dear Colleagues:

Enclosed are the Academic Salary Scales for 2006-07, with pay rates effective October 1, 2006. With a few exceptions below, the scales have been increased by a 2% general range adjustment.

Special salary adjustments have been made for the following scales:

- In accordance with the agreement between the UAW and the University of California, the salary scales for Academic Student Employees (ASE) in Tables 20, 21, and 22, have been adjusted by a 3.5% increase, effective October 1, 2006. For titles in the bargaining unit whose rates are not maintained by the Office of the President, namely the *Tutor* titles systemwide as well the *Associate in _____*, the *Acting Instructor-Graduate Student*, and *Reader* titles at the Berkeley campus, each campus will need to ensure that this 3.5% increase is implemented. In addition, employees in the teaching titles who are not in the ASE bargaining unit, e.g., Readers, Remedial Tutors, and Tutors at the Santa Cruz campus, and Reader, Remedial Tutors, Tutors, Teaching Assistants and Teaching Fellows at UC San Francisco, UCDC and EAP, should receive the same increase as those ASE's in the bargaining unit received, the 3.5% salary increase effective October 1, 2006.
- In accordance with the agreement between the AFT and UC, the salary rate for Assistant Librarian, Step I, in Table 31A, has been increased to \$40,008 effective October 1, 2006. Additionally, the hourly rate for the Hourly Intermittent Librarian, Step I, in Table 31B, has been increased to \$19.16 effective October 1, 2006.

The salary scale for the Professional Research Series, Fiscal Year, for Business/Management and Engineering (Table 16) has now been collapsed to a single rate for each step.

The salary scales for Lecturers and other Non-senate Instructional Unit 18 titles (Tables 17, 18, 19, 37, 38A, 38B) have been adjusted by a 2% general range adjustment for both represented and non-represented employees.

The salary scale for House Staff (Table 23) has been increased by a 2% general range adjustment for both represented and non-represented employees.

The salary scales for Research Assistants and Graduate Student Postgraduate Researchers are no longer published as they have now transferred to either the Graduate Student Researcher title or the Graduate Student Assistant Researcher title, and to its corresponding salary scale (Table 24).

The salary scales for Librarians (Tables 31A and 31B) have been adjusted by a 2% general range adjustment, with the exceptions noted above for Assistant Librarian, Step I, and the Hourly Intermittent Librarian, Step I, for both represented and non-represented employees.

The salary scale for Continuing Education Specialists (Table 35) continues to be published until they transition to the new Continuing Educator salary scale (Table 36), which was introduced last year.

The Faculty Recruitment Allowance table (Table 45) was formerly termed the Salary Differential Housing Allowance Program.
