
## ADRIANA GALVAN Dean, Undergraduate Education and Professor of Psychology UCLA

Dr. Adriana Galván is a Professor of Psychology and the Dean of Undergraduate Education at the University of California, Los Angeles who is committed to improving the scientific understanding of the period of adolescence. She is also the Co-Executive Director of the UCLA Center for the Developing Adolescent.

As a neuroscientist her career has been focused on adolescent brain development and how it supports developmental milestones during this significant developmental window. Her research expertise focuses on characterizing the neural mechanisms underlying adolescent behavior to inform policies that impact young people.

Dr. Galván has published over 130 scientific articles on the topic and is the author of The Neuroscience of Adolescence (Cambridge University Press). Her research, generously funded by the National Institutes of Health, National Science Foundation, and numerous private foundations, has been featured in several media outlets including The New York Times, Washington Post, PBS NewsHour, and NPR. She received her B.A. in Neuroscience and Behavior from Barnard College, Columbia University, and her Ph.D. in Neuroscience from Cornell. She has received multiple recognitions for her work, including from the National Academy of Sciences, American Psychological Association, Cognitive Neuroscience Society and William T. Grant Foundation. She is also the recipient of the UCLA Gold Shield Faculty Prize. In 2018 she was a Fulbright Scholar in Barcelona and in 2019 she received the White House Presidential Early Career Award for Science and Engineers (PECASE) award.





### AGAM PATEL Executive Director, UCR Palm Desert Center UC Riverside

Agam Patel is the executive director of the University of California, Riverside - Palm Desert Center. Currently. He is an advisory committee member for First 5 Riverside County Children and Families Commission.

He holds an MBA from United States International University in San Diego and a Bachelor of Science degree in accounting and finance from Nairobi, Kenya.

As Faculty Director of the UCSB Natural Reserve System, Cottle is committed to supporting university-level teaching, research, and public service while developing and implementing a plan to enhance infrastructure, bolster staffing, and establishing a systems-based approach to studying and conserving protected natural areas throughout California.

Cottle's expertise extends beyond academia. He served as Chief Scientific Advisor for Antarctica New Zealand, authoring the "Aotearoa New Zealand Antarctic Research Directions and Priorities" Document, a decadal-level research strategy defining New Zealand's investment in Antarctic and Southern Ocean research. This role required significant engagement with national and international stakeholders, navigating complex policy needs and research requirements, and giving voice to multiple knowledge-based approaches. Following ministerial approval, the document serves as a guide for Aotearoa's research program in Antarctica.

Cottle's own research focuses on continental tectonics and geochronology. Over the past twenty-five years, he has pioneered new analytical methods to unravel the geological history of major mountain belts, including the Himalaya, Antarctica, and New Zealand. His extensive research has resulted in over 175 academic publications and numerous awards, including the Antarctic Service Medal and Fellowships from the Mineralogical and Geological Societies of America.


significant institutional progress. With expertise in managing budgets, HR, IT, facilities, and long-term project planning, Tasha's role includes critical training and employee engagement initiatives.
