# UNIVERSITY OF CALIFORNIA

## 2024 Contracting for Services at Newly Developed Facilities Reporting Period: Calendar Year 2024 (1/1/24 - 12/31/24)

Section 92611.9 of the Education Code states:

It is the intent of the Legislature that the University of California carefully monitor the use and effects of the contracting of services at newly developed facilities. In order to assist in an improved understanding of such impacts, the university is requested to report annually to the fiscal committees of the Legislature, on or before January 15 of each year, the extent to which it has chosen to contract for services, the rationale for those decisions, the cost implications of those decisions, the impact on hiring, and the extent to which the hiring and contracting practices are at variance with the practices at existing facilities.

The University of California submits this report in response to the above request of the Legislature. This report covers activities from January 1, 2024 through December 31, 2024 for newly developed facilities defined as those that opened or began operations on or after January 1, 2024. The university is dedicated to the insourcing principles articulated in its policies and collective bargaining agreements (CBAs).

Certain limits apply to when the University can contract for services. Considerations that must be taken into account are:

- Regent's Policy 5402: Policy Generally Prohibiting Contracting for Services,
- compliance with other university policies and CBAs,
- compliance with applicable Business and Finance Bulletins governing service contracts and professional agreements,
- compliance with requirements of personnel policies,
- business and financial necessity,
- level and quality of service required (including special skills and expertise),
- impact on the local business community, and
- impact on the core University functions of teaching, research, service, and patient care.

In 2023 and 2024 the University of California Health Systems acquired additional hospitals at multiple locations. Access to health care is a fundamental need for all people in California. These acquisitions by UC Health locations will expand UC-provided care provided to more communities and patients. They will also create new models that help patients get a full spectrum of care through a comprehensive, integrated network.

No University staff were displaced as a result of these acquisitions, and they are not expected to result in reductions in jobs at UC or at the newly acquired facilities. In fact, projections for the resulting combined organizations generally show growth in positions in the years following the acquisitions. Although there are many contracts for services with these facilities, each UC location is managing those agreements closely to determine the appropriate strategy to address near-term and long-term staffing needs. Some contracts will be insourced, and others extended, all with an eye to compliance with UC's labor relations obligations as well as our commitment to quality patient care and safety.

## **Report Results**

Per University guidelines on contracting activities, contracts that may result in the displacement of University staff and that exceed \$100,000 per year require advance review by the Office of the President prior to any contracting commitments. In calendar year 2024 no such contracts were sent by locations for review. No service contracts were reported at newly developed facilities at UC Agriculture and Natural Resources, UC Berkeley, UC Merced, UC Santa Barbara, UC Santa Cruz, and UC Office of the President.

## Summary of Non-Hospital Acquisition Facilities:

During calendar year 2024, one (1) UC location reported a total of seven (7) contracts for services at newly developed/leased non-hospital acquisition facilities in the University system and no University staff were displaced as a result of these activities.

The 7 contracts (excluding lease agreements with predetermined services) for services at newly developed facilities for 2024 are as follows:

• UC Riverside reported three (3) newly developed/leased facilities with seven (7) contracts in place for elevator maintenance, custodial, high rise window cleaning, exterior pest control, and waste removal services.

Brief summaries of these contracts for services are found in Appendix A attached to this report.

Additionally, four (4) locations reported ten (10) total newly leased facilities that included predetermined services in the overall lease agreement. No University staff were displaced at the campuses or medical centers as a result of these contracting activities.

In these situations, the University is not contracting for services directly.

#### Summary of Hospital Acquisitions:

During calendar year 2024, three (3) UC locations reported a total of one thousand seventy-nine (1,079) contracts for services at newly developed/leased hospital acquisition facilities in the University system and no University staff were displaced as a result of these activities.

The 1,079 contracts (excluding lease agreements with predetermined services) for services at newly developed facilities for 2024 are as follows:

- UC Irvine reported fourteen (14) newly developed/leased facilities with one thousand sixty-eight (1,068) contracts in place, which include biomedical maintenance/repairs, instrument/scope repairs, electrician services, HVAC maintenance, plumbing, nurse staffing, etc.
- UC Los Angeles reported one (1) newly developed/leased facility with seven (7) contracts in place for security, EEG, neuromonitoring, landscaping, perfusion, and housekeeping services.
- UC San Francisco reported two (2) newly developed/leased facilities with four (4) contracts in place for patient chart audit services, radiation therapy consulting, and retrospective and registry abstraction.

Brief summaries of these contracts for services are found in an Excel spreadsheet transmitted with this report, in the tab labeled "Appendix B."

Additionally, one (1) location reported twenty-four (24) total newly leased facilities as part of the hospital acquisitions that included predetermined services in the overall lease agreement. No University staff were displaced at the medical centers as a result of these contracting activities.

## Amendment to 2023 Report:

## Summary of Hospital Acquisitions:

One (1) location reported twenty-five (25) contracts (that do not include pre-determined services) for services at newly developed hospital acquisition facilities in the University system which should have been reported in 2023. These totals are not included in the 2024 contract counts. No University staff were displaced at the campuses or medical centers as a result of these activities.

• UC San Diego reported one (1) newly developed/leased facility with twenty-five (25) contracts in place for maintenance, custodial, groundskeeping, and security services.

## Appendix A

## UC Riverside

UC Riverside (UCR) entered into seven (7) contracts at three (3) newly developed/leased facilities:

- 1. <u>1420 Iowa Ave, Riverside 92507</u>
  - a. The location entered into a contract for elevator maintenance with Kone, as facilities staff does not provide this service. The services are contracted to run from January 1, 2024 through December 31, 2024. No UC staff were laid off or reassigned as a result of this contract.
  - b. The location entered into a contract for custodial (floor care) with Max Steam, as facilities did not have the proper equipment to provide this service. This was a one-time cleaning related to a project to renovate a large office area. The services were contracted to run on November 20, 2023. No UC staff were laid off or reassigned as a result of this contract.
  - c. The location entered into a contract for high rise window cleaning with Dutch Touch, as facilities did not have the proper equipment to provide this specialty service. The services were contracted to run on October 15, 2024. No UC staff were laid off or reassigned as a result of this contract.
  - d. The location entered into a contract for exterior pest control with Western Exterminator, as facilities staff does not provide this service. The services are contracted to run from January 1, 2024, with no contract end date. No UC staff were laid off or reassigned as a result of this contract.
  - e. The location entered into a contract for waste removal with Burtec, as facilities staff does not support off site waste removal. The services are contracted to run from January 1, 2024, with no contract end date. No UC staff were laid off or reassigned as a result of this contract.
- 2. School of Medicine Education II, 900 University Ave, Riverside 92507
  - a. The location entered into a contract for elevator maintenance and repairs with Kone, as facilities staff does not provide this service. The services are contracted to run from August 1, 2024 through December 31, 2024. No UC staff were laid off or reassigned as a result of this contract.
- 3. Student Health & Counseling, 900 University Ave, Riverside 92507
  - a. The location entered into a contract for elevator maintenance and repairs with Kone, as facilities staff does not provide this service. The services are contracted to run from August 1, 2024 through December 31, 2024. No UC staff were laid off or reassigned as a result of this contract.
