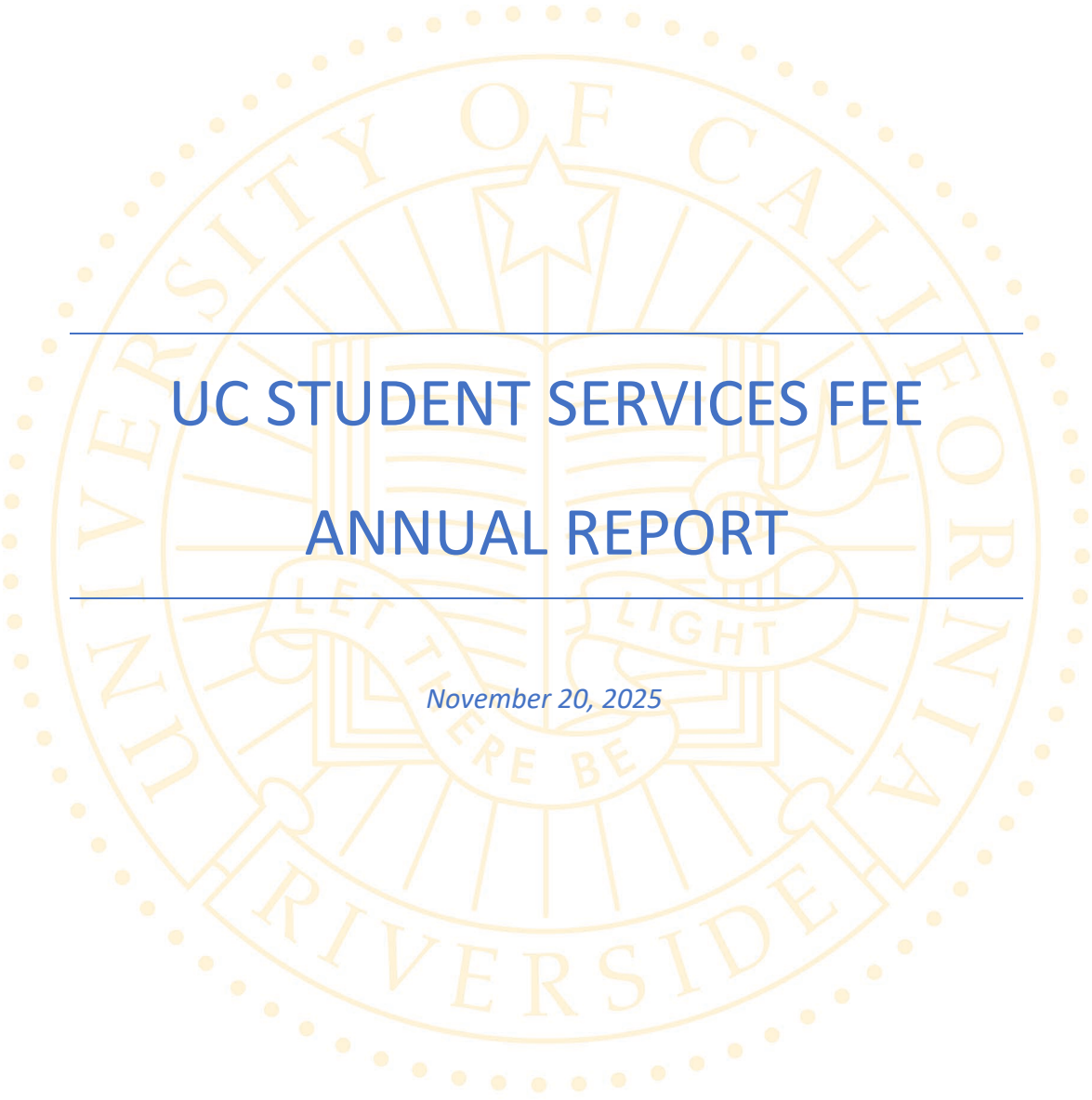

- 1) Describe how 2024-25 Student Services Fee (SSF) revenue was used on the campus. To what extent did SSF revenue uses diverge from original plans? If SSF revenue diverged from the original plan, please explain.

In 2024-25, Student Services Fee (SSF) revenue continued to be allocated through the established governance process under the purview of the Vice Chancellor for Student Affairs (VCSA) and the Student Services Fee Advisory Committee (SSFAC). The SSFAC supported by Student Affairs leadership and the campus Central Budget Office, reviewed proposals, analyzed UCR's financial context, and recommended allocations that aligned with Regents Policy 3101 and the fee's purpose of supporting student-facing services, programs, and resources.

Across SSF-funded units, revenue was used to sustain and enhance student services that promote engagement, belonging, well-being, and academic success. Departments prioritized expanding student success and engagement centered programming; reimagining signature events; strengthening campus traditions; and improving hiring practices for student employees to support the student body. These investments supported initiatives focused on developing critical thinking, fostering respectful dialogue, and promoting cultural understanding and leadership development.

The annual call for proposals followed the standard cycle, but enhanced for critical analysis: proposals were issued at the end of fall quarter, departmental presentations and subcommittee reviews occurred during winter and spring, and final recommendations were submitted to the VCSA for approval. Subcommittees conducted deeper functional and financial reviews of requests, and funded units received allocations only after committee evaluation and VCSA approval. Final allocations were also provided to the Chancellor for recordkeeping.

SSF revenue uses in 2024-25 did not materially diverge from the original plans approved during the proposal and review cycle. All departments requesting funding submitted proposals through the standard process, and allocations were made consistent with committee recommendations and within available revenue. Any minor adjustments were operational in nature (e.g., aligning staffing timelines or program deployment with hiring cycles or student demand) and did not alter the intended purpose or scope of approved uses. As a result, SSF expenditures remained aligned with the committee's initial priorities and the campus's overarching student support goals.

2) Describe your campus's consultation process with your local Student Fee Advisory Committee. Did the consultation process change in Spring 2025? If yes, to what extent?

UCR's consultation process with the Student Services Fee Advisory Committee (SSFAC) remained consistent and aligned with established campus practice.

The SSFAC operates under the purview of the Vice Chancellor for Student Affairs (VCSA), who along with key members of the VCSA Administration Unit regularly meets with the committee to provide guidance, set expectations, and support the committee's work in prioritizing and evaluating funding requests in accordance with Regents Policy 3101. Departments seeking new or augmented SSF funding continued to present proposals through this established process.

To ensure the committee had the context needed for informed decision-making, the Central Budget Office participated in the consultation process again this year, presenting campuswide financial reports and partnering with Institutional Research to share enrollment trends and projections. This collaboration supported a more comprehensive understanding of UCR's financial landscape as the committee considered proposals.

The committee itself is composed of 13 voting members—undergraduates, graduate students, faculty, and staff—reflecting a broad cross-section of campus stakeholders. Two staff members serve in a support and liaison role to the VCSA, attending all SSF meetings including subcommittee deliberations.

Overall, the consultation approach did not change in Spring 2025. The structure, roles, and engagement model remained stable, ensuring continuity and transparency in how the campus consults with the SSFAC.
