Definition of Laboratory Buildings

As outlined in IRM 1, Addendum E

Updated: 17-Jun-08

To be considered a lab building, the building must meet the following standards:

- 1. At least 25 percent of the total assignable square feet withing the building must be laboratory space, or
- 2. The building must contain at least 7500 assignable square feet of laboratory space.

Laboratory space is determined by the following Room Use codes with the following Program Codes:

Changes from Prior Versions

Update17-Jun-08 from Definition Published in IRM 1, Addendum E dated 1-Nov-00

- At the Riverside campus, there is no Facility Department titled ANACHEM that is associated with Program Code 2130. Based on the list of facility codes from the 2007 CRIS extract, Program Code 2130 has the facility department AP Center associated with it. ANACHEM is associated with Program Code 3130. The 17-Jun-08 updated definition for RV lab buildings has been modified to include 2130 (Air Pollution Center) and 3130 (ANACHEM, Genomics and Plant Transf).
- At the UCLA campus, there are no Facility Departments associated with Program Code 3130. This part of the original definition was excluded in the 17-Jun-08 update.
- At the Santa Barbara campus, there are no Facility Departments associated with Program Code 3130. This part of the original definition was excluded in the 17-Jun-08 update.
- At the San Diego campus, there were three Facility Departments associated with Program Code 3130 include Cross Culture, LGBT and Women's Center. These are not bench research departments and, as of 17-Jun-08, the definition for lab space at the San Diego campus no longer includes this Program Code.
- At the UCLA campus, the Facility Departments associated with Program Code 230900 is the CRUMP Institute of Molecular Imaging, not the Jerry Lewis Neuromuscular Research Center. The 17-Jun-08 updated definition for LA lab buildings dropped the Jerry Lewis Neuromuscular Research Center facility department and added the Crump Institute facility department.
- At the Berkeley campus, expanded the Facility Department Codes associated with 3130 to include CITRIS, QB3 Institute and the UC Energy Institute.
