

Use of Proposition 56 Funding: 2021-2022 Appropriation

In 2018, University of California Health (UCH) entered into an agreement with Physicians for a Healthy California (PHC) for the purpose of developing, administering, and managing a statewide Graduate Medical Education (GME) grant program (known as “CalMedForce”) created and funded by Proposition 56.

Application Period: August 2, 2021 through September 17, 2021

Award notification: November 17, 2021

Total award amount: \$39,070,000¹

First payment to 2021-2022 awardees sent/approved in Fall of 2022. Subsequent payments, over the course of three or four years, are made upon approval of required reports per the CalMedForce program.

¹ Per the agreement between UC and PHC, \$1,500,000 is paid annually to PHC to manage and administer the CalMedForce program annually. Overpayment will be tracked and used in 2022-23 for management and administration costs.

² Funds allocated to PHC for payment to grant recipients. Payments are made upon approval of required reports, over a three or four-year contract depending on specialty.

⁴ Funds submitted for processing to the State Controller's Office.

⁵ Total expenses once funds submitted to the State Controller's Office are processed and paid.

⁷ After re-examining total funds allocated from Prop 56 and State General Funds, total available funding was less than \$40,000,000. Funding is annually appropriated, and adjustments made in 2022-2023 and 2023-2024 to account for overspending in 2021-2022.
