

## Use of Proposition 56 Funding: 2021-2022 Appropriation

In 2018, University of California Health (UCH) entered into an agreement with Physicians for a Healthy California (PHC) for the purpose of developing, administering, and managing a statewide Graduate Medical Education (GME) grant program (known as “CalMedForce”) created and funded by Proposition 56.

Application Period: August 2, 2021 through September 17, 2021

Award notification: November 17, 2021

Total award amount: \$39,070,000

First payment to 2021-2022 awardees sent/approved in Fall of 2022. Subsequent payments, over the course of three or four years, are made upon approval of required reports per the CalMedForce program.

<sup>1</sup> Per the agreement between UC and PHC, \$1,500,000 is paid annually to PHC to manage and administer the CalMedForce program annually. Overpayment of \$203,762.33 was used in subsequent years for management and administration costs and/or to cover deficit from Prop 56 funding decline.

<sup>2</sup> Funds allocated to PHC for payment to grant recipients. Payments are made upon approval of required reports, over a three or four-year contract depending on specialty.

<sup>3</sup> Funds claimed by UC award recipients from the November 2025 State Controller's Office report.

<sup>4</sup> Claims submitted for processing to the State Controller's Office and pending as of November 2025.

<sup>5</sup> Total amount once funds submitted to the State Controller's Office are processed and paid.

<sup>7</sup> Total available funds allocated from Prop 56 and State General Funds were less than \$40,000,000 after reviewing the final budget information from the State in November 2022. Funding is annually and continuously appropriated, and adjustments made in 2022-2023 reduced the deficit from 2021-2022 cycle.
