

Use of Proposition 56 Funding: 2022-2023 Appropriation

In 2018, University of California Health (UCH) entered into an agreement with Physicians for a Healthy California (PHC) for the purpose of developing, administering, and managing a statewide Graduate Medical Education (GME) grant program (known as “CalMedForce”) created and funded by Proposition 56.

Application Period: August 2, 2022 through September 16, 2022

Award notification: November 17, 2022

Total award amount: \$37,955,000

First payment to 2022-2023 awardees sent/approved in Fall of 2023. Subsequent payments, over the course of three or four years, are made upon approval of required reports per the CalMedForce program.

¹ Per the agreement between UC and PHC, \$1,500,000 is paid to PHC to manage and administer the CalMedForce program annually. Overpayment from 21-22 to PHC of \$45,917.21 was used in 2022-23 for management and administration costs.

² Funds allocated to PHC for payment to grant recipients. Payments are made upon approval of required reports, over a three or four-year contract depending on specialty.

⁴ Funds submitted for processing to the State Controller's Office and pending as of November 2025.

⁵ Total amount once funds submitted to the State Controller's Office are processed and paid.

⁷ After re-examining total funds allocated from Prop 56 and State General Funds, total available funds was \$40,002,000. However, since prior carryforward amount was negatively large and funds are continuously appropriated, further adjustments will be made in the subsequent years to account for deficit from the previous years.
